YOUR WARRANTY PROTECTION

Lifestyle Home Products and Lifestyle Sunrooms Inc. (Lifestyle) build vinyl windows to meet or exceed industry standard. Our products are tested and comply with the Canadian Standard Association for manufacturing windows as set out in the CSA standard, A440. Lifestyle guarantees its vinyl windows against faults in manufacturing and defective materials through a lifetime warranty. This document sets out the various warranties Lifestyle extends to the original purchaser of its fully assembled vinyl windows (products). Our warranties are subject to the conditions, exclusions and limitation contained in this document. This warranty applies to products manufactured by Lifestyle from and including April 1st, 2005.

LIFETIME WARRANTY ON WHITE WINDOW FRAMES AND SASHES

- A. Vinyl Frame and Vinyl Sash Components:** That the vinyl frame and vinyl sash components will be free from manufacturing defects and will not rot, pit, peel, flake, split, blister or corrode. White frames and sash material carry a limited lifetime warranty. Coloured vinyl products are protected by a 10-year warranty from the date of delivery.
- B. Hardware Components:** The hardware is covered by a limited lifetime warranty from the date of delivery. Screen mesh has no warranty.
- C. Glass Panels:** That the insulated glass panels will not suffer formation of condensation on the inner surfaces, caused by seal failure, carries a limited lifetime warranty.

REMEDIES

Where a defective product or component of a product manufactured by Lifestyle is deemed defective and covered by this warranty, the remedies of the original purchaser are limited to the following:

1. Repair of the defective product or component;
2. Replacement of the defective product or component;
3. Refund of the original purchase price of the defective product or component;
4. All remedy costs are prorated for the term of the warranty period as follows:

Lifestyle's liability under this warranty shall in no event exceed the purchase price of the defective product or component and in all cases removal, shipping, painting, refinishing, installation and other similar costs are not covered. Claims shall be presented to Lifestyle by the original purchaser only together with the elected remedy and direct cost justification.

WARRANTY ASSIGNMENT

This warranty is transferrable to future owners of the property, Lifestyle's obligation will only continue if notice of transfer in ownership is forwarded to Lifestyle within 30 days of transfer along with a \$250.00 administration fee. The warranties provided herein are extended, as defined in the section "Your Warranty Protection".

EXCLUSIONS

Lifestyle shall not be liable for, and this warranty does not apply or extend to: glass shattering, breakage or distortion, or to any failure, defects of damage arising from or connected with, without limitation, misuse, neglect, physical abuse, faulty or improper installation or insulation, painting, coating or laminating, modifications or attachments not authorized by Lifestyle, any component or part supplied by Lifestyle, owner failure to provide reasonable and necessary maintenance to prevent an accumulation of surface dirt, staining or mildew, use of harmful cleaning products, failure of/or damage to walls, surfaces or structures to which products are installed arising from settlement, movement, or cracking thereof, earthquakes, hurricane, tornado, lightning, fire, flood, and environmental circumstances beyond one's control, accidental or intentional damage, vandalism, colour changed arising due to normal weathering, exposure to ultraviolet light, extremes of weather and atmospheric conditions (such as acid rain) which causes accumulation of dirt or stains, oxidation of corrosion and all other causes beyond Lifestyle's control.

Lifestyle will not be liable for any consequential, incidental, special or indirect losses. The only remedy with respect to losses of damages however they may be caused and whether due to negligence of other cause will be as specified in this document ("remedies"), which are the sole and exclusive remedies.
